# **About Culture Moves Europe and your application**

## **ABOUT THE SCHEME**

<u>Culture Moves Europe</u> is the permanent mobility scheme funded by the <u>Creative Europe</u> programme of the European Union and implemented by the <u>Goethe-Institut</u>.

Culture Moves Europe provides mobility grants for artists and cultural professionals in all 40 Creative Europe countries. It covers the sectors of architecture, cultural heritage, design and fashion design, literature, music, performing arts, and visual arts.

## **ELIGIBILITY**

## How the budget is calculated

The budget is calculated per person and has two main parts. First, a Mobility Grant for travel and daily costs (everyone gets this).

Then, extra top-ups and accessibility support (based on individual needs).

## **Mobility Grant:**

- Daily allowance: 75 euros per day; or 35 euros per day for virtual projects. This is a contribution towards costs such as food and accommodation in the destination country.
- o **Travel allowance:** 350 euros for a travel distance of less than 5,000km (one-way); or 700 euros for a distance of 5,000km or more.

## **Top-ups and support:**

- Green mobility top-up: a grant of 350 euros to support those who choose sustainable means of travel from the place of residence to the place of destination and back to the place of residence. This includes all forms of transport except airplanes. It can only be granted for journeys of 600 km and above (distance calculated one way on a straight-line basis), and for eligible travel routes.
- OCT/OR top-up: 150 euros to support applicants whose place of residence and/or place of destination is an OCT or OR.
- o **Visa top-up:** 80 euros to contribute to expenses connected to visa processing.
- Family top-up: 100 euros to support A&CPs with custody of children below the age of 10 during the mobility project. This is a fixed amount regardless of the number of children.
- Accessibility support: additional financial support for grantees who are deaf or have a
  disability, to help cover specific additional costs connected to the project implementation
  and/or the travel from the place of residence to the destination (and back).

Supporting documents are requested at application and reporting stage to prove you are eligible for requested top-ups or support.
